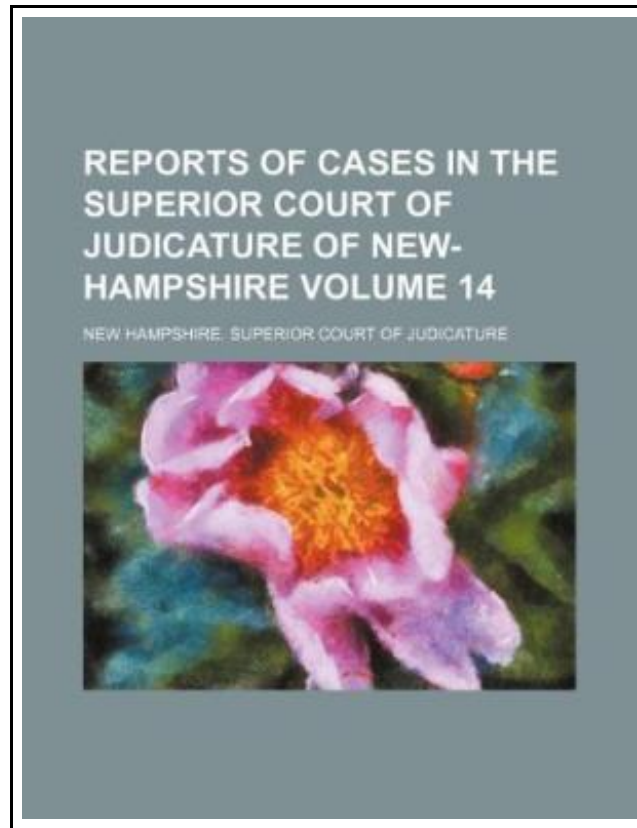

Where such a contract is rescinded, it is sufficient if the property be returned, within a reasonable time, in substantially the same condition in which it was received. In case of fraud in the sale of real estate, a deed of quitclaim, made six months after the purchase, was held within a reasonable time; it not appearing that the fraud was sooner discovered. Where such a deed was left with the clerk of the court in which an action on the note, given in consideration of the sale and conveyance of the estate, was pending, and notice was given, to the vendor, of the execution and deposit of the deed, it was held a sufficient restoration of the property. A principal is chargeable with the fraudulent acts and declarations of a special agent, done and made for the purpose of effecting a sale, though not commissioned to commit a fraud. Even where a party could not recover damages against a principal on account of the fraudulent...
